1. Validity and application of the Rules and Conditions

Blue Orange, organizer of the tournament, reserves the right to modify the present rules at any time if it deems it necessary. It is the participant's duty to check that he or she has the latest version of these rules. Participation in this online tournament implies the participant's full and complete acceptance of the present rules and the terms and conditions of the game.

2. Conditions of registration

To register for the online tournament, the participant must complete the registration form that was sent to him/her by email.

It is up to the participant to verify the accuracy of the information he provided on the online tournament registration form. This information is necessary for the organisation of the competition.

3. Tournament format and procedure

The competition to which these rules apply is in the form of an online tournament on the digitized version of Kingdomino on the Board Game Arena website, the details of which are as follows:

Each player will be assigned a first match to qualify to the final match and get a chance to win the tournament. The first match will be a 4 or 3 player match on Board Game Arena. The players have a fixed deadline to play this first match and report the winner (We recommend each winner to keep a proof of their victory, via a screenshot or by recording the game with the consent of the other players for example). Each winner of the first game will face the other winners on a 4-player match of Kingdomino on Board Game Arena. This match will have a fixe date and time communicated to the players by mail. The champion of the tournament will be the winner of this final match.

As previously mentioned. You have to arrange the date and time of your match between yourselves (i.e the players). Should one or more of your designated opponents fail to respond to your emails, or those sent by other players of your table, making it impossible to plan your qualification match, please inform us before

August the 16th. If you are the difficult person to contact, please note that you risk disqualification from the competition.

You will have to fix a date with the 3 other designated players of your table to play this unique 4-player match on BGA. This match must be played in real-time game and with no additional rules (harmony and middle kingdom).

4. Application of penalties

Penalties may be applied by the administrators during the tournament for the participant if one or more of the following factors are present:

Absence of the participant from the tournament:

If the participant is absent for the entire competition and has not participated in the compulsory matches, he will be considered disqualified from the tournament. It is up to the participant to coordinate with the other players to play the compulsory matches.

Consequent delay from the participant:

If the participant is subject to a consequent delay after the beginning of his matches, it is up to the organizers of the tournament to choose if the participant can compete or if he is subject to an absence (read the section "Absence of the participant from the tournament").

Cheating:

In the case of proven cheating, the participant will be excluded from the tournament by one of the organizers with immediate effect.

Abuse of language and inappropriate behaviour:

By participating in the tournament, all participants agree to behave courteously towards their opponents as well as towards members of the organization and Board Game Arena. Should a participant fail to respect this rule, a penalty may be imposed ranging from a warning to exclusion.

5. Broadcast / image rights

The final of the tournament will be broadcasted and commented live on the various Blue Orange social medias, as well as on the Board Game Arena website.

The information of the participants, particularly the winners, may be used for the needs of the organisation of the tournament and in the communication made around the tournament, in particular on the social medias of Blue Orange and Board Game Arena.

The participants authorise Blue Orange and its partners to fix, record and reproduce its image by all technical means known to date. The participant's image may therefore be broadcasted on any medium chosen by Blue Orange and their partners for communication purposes. In addition, the participants authorise Blue Orange and its partners to disseminate its image to the public using the various means known to date, and in particular the Internet.

6. Terms and conditions for awarding the prizes

The prize(s) will be awarded to the winner(s) of the tournament as soon as possible after the announcement of the winner(s).

Blue Orange reserves the possibility, in the event of a problem, in particular related to the different regulations in the countries of the participants, to replace one of the prizes offered by a prize of the same value.

All players will receive the equivalent of approximately €200 worth of Blue Orange board games (public price). The finalists will receive a one-year premium subscription to the Board Game Arena website. The winner of the tournament will receive €3,000.

7. Data protection and freedom of information

The information and data provided on the registration form concerning the participants are necessary to ensure the smooth running and management of the online tournament. This information will be used for the management of the tournament and the delivery of the various prizes. In accordance with the French Data Protection Act, you have the right to access, rectify and oppose any personal data concerning you. To do so, simply contact us by email.

8. Responsibilities of the organizer

Blue Orange reserves the right to shorten, extend, modify, refute, and cancel this online tournament if circumstances require it. Its responsibility cannot be engaged as a result.

Blue Orange commits to give the prizes to the winners of the online tournament as soon as possible at the end of the tournament.

Blue Orange commits to manage the tournament with organisers who will be available for the participants throughout the entire tournament.
